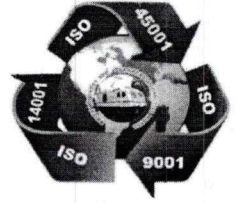


Ref.: Board's letter No. E(P&A)I-2021/HL-1 dated 04.02.2022 (RBE No. 14/2022).
