Item No. 16/2021 of DC/JCM (Railways). Staff Side Demand:-

"Railway Board's instructions vide letter dated 31/08/2015, Para (xi) provide that in case of non-gazetted Railway employees, no inter Railway transfer requests be considered till completion of five (05) years of joining the Railway. Though exemptions were granted from the condition of a minimum of five (05) years service in certain specified cases vide Board's instructions contained in RBE No.12/2017 dated 10/02/2017, the Railway Board issued instructions subsequently vide RBE No. 153/2019 dated 20/09/2019 stating that henceforth only such inter-Railway transfer requests be forwarded where there is reasonable possibility of relief in case of acceptance by the Railway to which transfer is sought. While doing so, various factors like number of staff likely to be inducted in the cadre by way of departmental promotions/Inter-Divisional/Inter-Railway Transfer from other Railways/Divisions and through RRB indents should be kept in view so that once NOC is received, the concerned employee can be relieved soon.

Board's instructions dated 20/09/2019, have created negative impact on the Divisional/Zonal Administration who have wrongly interpreted and declined to forward inter Railway/Division/Unit transfer applications of Railway employees, citing the reason of more than 10% vacancies even after joining of new RRC/RRB candidates. Consequently, the staff have been put to severe hardships as they are unable to move out of on transfer despite the fact that they have completed more than five years service.

Staff Side requests the Railway Board to consider the above points and see that proper decision is taken for providing quick replacement through various sources to facilitate Inter Railway/Inter-Divisional transfer applicants join at new places of their choice."
