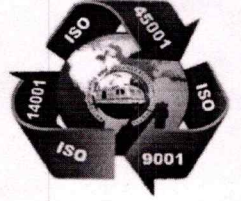

Please refer to Board's letters No. PC-VII/2017/I/7/5/8 (RBE No. 127/2019) dated 08.08.2019 and dated 11.05.2020 regarding clarification on restriction of officiating pay under FR-35 in context of RS(RP) Rules, 2016.
